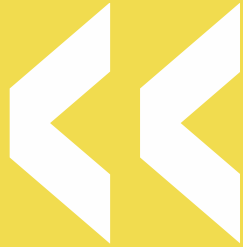

THE RULE IS...

A set of principles, regulations and recommendations, intended to help members of the Society of Saint Vincent de Paul to live according to the spirit and traditions of the association

THE VARIOUS VERSIONS OF THE RULE

The 1835 Rule: in effect for 140 years

To put in writing the practices and usages of the emerging Society

The 1973 Rule: In effect for 30 years

Purpose: To incorporate the contribution of Vatican II

The 2003 Rule: used today

Purpose: To incorporate the international nature of the Society

“The Rule and Statutes”

is the expression used to describe the

Rule of 2003 as a whole, with its 3 parts



THE PRESENT RULE HAS 3 PARTS

I. **“The Rule”**, which summarizes our spirituality

II. **“The statutes of the International Confederation”**

This covers the internal regulations of the international association

III. **“The conditions to be applied in writing internal statutes for superior, assimilated and associated councils”**

These are the provisions that have to be included in the various Rules for National/Superior Councils



PART 1: “THE RULE”, A SUMMARY OF OUR SPIRITUALITY

This part concerns **all Vincentians**. It describes

1. **The 3 essential dimensions of the Society**

(chapters 1 to 3)

1. HORIZONTAL
Towards the poor whom we serve
2. VERTICAL
To God through Christ: holiness and virtues
3. COMMUNAL
Friendship, mutual support, Servant Leaders, Councils and Youth
(forms a circle around the cross formed by the other 2 dimensions)



PART 1 (cont): “THE RULE”, A SUMMARY OF OUR SPIRITUALITY

It also describes

2. The relations of the Society of Saint Vincent de Paul with the outside world (the network of Charity)

(chapters 4 to 7) These relations are like 4 widening circles, from the nearest to the furthest.

Relations:

4. Between countries – Twinning and Vincentian Family
5. With the Hierarchy
6. With other Churches, Faiths and Agencies
7. With civil society – Social Justice



PART 2: “THE STATUTES OF THE INTERNATIONAL CONFEDERATION”

This part mainly concerns **international officers and membership**
It describes the Society as

- An international association under French law, whose members are the Superior Councils of each country.

There are two conditions for legal membership of the International Confederation. Councils must:

- ✓ Be instituted
- ✓ Be recognised as a legal entity in their own country

PART 2: “THE STATUTES OF THE INTERNATIONAL (cont) CONFEDERATION”

The 2nd part of the Rule also describes

- the mission of the various governing bodies of the international association
- The procedures to follow for Aggregation of Conferences and Institution of Councils

These two terms signify full membership of the Society of Saint Vincent de Paul. The Council General officially recognises that a Council or Conference is living according to the Rule of the Society

PART 3: “BASIC REQUIREMENTS FOR WRITING INTERNAL STATUTES”

This part concerns **all countries and therefore all Vincentians**

The rules of a Superior Council are called its “Internal Statutes”. They must include

- **A variable part,**
with the laws, usages and traditions proper to each country
- **A fixed part common to all countries**
The internal statutes are produced from the model statutes in Part III and called “Required Conditions”.

AN ASSEMBLY MAKES DECISIONS ON THE STRATEGIC DIRECTION OF THE SOCIETY

General Assembly
of the International Council

MEETS EVERY 6 YEARS

- Makes decisions on the strategic direction of the society
- Makes decisions on changes to the “Rule and Statutes”
- Elects the new International President
- Approves annual accounts
- Presents the budget

Restricted annual assembly
called the “International Executive
Committee” (IEC)

MEETS EVERY YEAR

- Approves annual accounts
- Presents the budget for the coming year
- Follows implementation of decisions taken at the General Assembly
- Decides strategy for the next year

MANAGEMENT OF CURRENT AFFAIRS

Task given to a particular decision-making body called the “Permanent Section”

- Acts as a Board of Administration in French Law
- Monitors the Society’s work around the world (including conflict resolution)
- Displays the work of the Commissions
- Deals with Aggregations and Institutions
- Deals with internal statutes
- Validates the decisions of the Development Commission
(Sending funds to countries for emergency aid, projects)

THE INTERNATIONAL PRESIDENT AND HIS/HER COLLABORATORS

- The International President
 - ✓ Represents the Society
 - ✓ Supervises, develops and coordinates the work of the Society around the world
- He/she is advised by the BOARD, which is formed of the President's closest collaborators
- He/she is assisted by specialist COMMISSIONS

The rules or articles of a Superior Council are called the “Internal Statutes”.

PROVISIONS THAT HAVE TO BE INCLUDED IN THE RULE OF EACH COUNTRY

Found in Part 3 of the Rule

3 types of provisions

- Those from Tradition
- Those that will help to solve problems
- Those that establish transparency in the use and management of assets

PROVISIONS FROM TRADITION

Concerning the life of the Conference

- The frequency and agenda for meetings
- Visiting those in need
- Annual report
- Annual review
- Commissioning ceremony
- Celebration of events and Vincentian feasts

Also concerning officers and decision-making

- Tasks of members of the Board
- Main principles: democracy, run by volunteer
- Role of Spiritual Adviser

PROVISIONS

THAT WILL HELP TO SOLVE PROBLEMS

- If members, conferences and councils are suspended
- A president's election can be declared null and void
- By creation of a reconciliation committee

PROVISIONS THAT ESTABLISH TRANSPARENCY IN MANAGEMENT OF ASSETS

- Requirement for an annual report and financial accounts
- Option of holding audits
- Statutes about property
- Guidelines for Youth Committee
- Guidelines for Special Works

QUESTIONS LEFT TO THE FREE CHOICE OF THE COUNTRIES

- Health and Safety
- Insurance
- Names of Councils
- Organisation of the association in each country
- Individual traditions
- Compliance with the legislation of each country

TO ENSURE FUNDING FOR THE INTERNATIONAL GOVERNANCE OF THE SOCIETY

- By contributions from Superior Councils
- By the personal contribution of each member:
(secret collections at meetings)
- By the financial commitment of the “Concordat”
17 countries undertake to pay Council General a certain amount – the same for 3 years
